QUALITY REPORT OF DEMOBAL AND URESPOP REFERENCE YEAR 2016

1. Introduction

This document provides a summary of the "Demographic balance data collection" for the reference year 2016 (DEMOBAL 2016) and of the "Usually resident population data collection" for the reference year 2016 (URESPOP 2016).

Some general aspects related to the data quality are reviewed, in particular referring to punctuality, completeness and availability of documentation.

The members of the Working Group on Population Statistics are invited to:

• Take note of the punctuality and completeness of the transmissions and of the availability of documentation for the respective data.

2. Demographic balance data collection reference year 2016

The data collection of the demographic balance for the reference year 2016 (DEMOBAL 2016) was launched in May 2017. The transmission deadline for the countries was 30th June 2017. The data collection is regulated by Regulation (EU) No 1260/2013¹ and Commission Implementing Regulation (EU) No 205/2014².

The following countries are participating to this data collection, some based on the above mentioned EU Regulations and some on voluntary basis: EU Member States, EFTA countries, EU Candidate Countries (Albania, Montenegro, the Former Yugoslav Republic of Macedonia, Serbia and Turkey), Andorra, Armenia, Azerbaijan, Republic of Bosnia and Herzegovina, Belarus, Georgia, Monaco, Republic of Moldova, Russian Federation, San Marino, Ukraine and Kosovo³. The national statistical institutes on these countries were requested to transmit to Eurostat data (dataset DEMOMIGR_DEMOBAL_A by Edamis⁴) and metadata (reported using the European Statistical System Metadata Handler⁵ (ESS-MH), dataset DEMOMIGR_BALESMS_A).

The data collection includes mandatory data defined by the EU Regulations (provisional data on total population, total live births and total deaths at national level) and voluntary data (provisional data on total immigration, total emigration, net migration and statistical adjustment if applicable).

2.1. Punctuality

The punctuality of the data and metadata supplied for this data collection has been assessed based on the deadline set by the Regulation (EU) No 1260/2013, which is 30th June 2017. The data request and accompanying documents were sent out in May 2017.

The data and metadata were to be transmitted using the Excel template prepared by Eurostat for the data transmission, and DEMOMIGR_BALESMS for the metadata.

Out of the 31 countries (EU-28 Member States and EEA countries) bound by the EU regulations⁶ above:

- 27 countries transmitted the required data before the deadline and four countries within 1 week of the deadline;
- 24 countries transmitted the required metadata before the deadline and six countries after the deadline; Norway has not sent yet the updated metadata.

As for the countries not bound by the EU regulations but participating on voluntary basis:

- Switzerland and five EU candidate countries, as well as Armenia, Azerbaijan, Bosnia-Herzegovina, Belarus, Georgia, Monaco, Russian Federation and San Marino transmitted the data before the deadline and Ukraine later;
- Switzerland and two EU candidate countries (Serbia and Turkey) transmitted metadata.


Therefore, regarding punctuality, 24 of the 31 countries bound by the above mentioned Regulation submitted the data and metadata within the mandatory deadline and seven countries later.

Eurostat acknowledges the efforts and thanks the data providers for the transmission of data and metadata within the deadline.

The increased importance and the need for timely and high quality data provision of DEMOBAL collection is due to the attention these statistics are getting from users and the general public. These

data cover user's information needs related to the first estimates on the demographic balance in the previous year (T-1) in beginning of July (year T), while the detailed information on population, births, deaths, immigrants and emigrants becomes available only in end-December (year T) in the UNIDEMO demographic collection.

The provisional data transmitted by the countries are published in beginning July of every year in Eurostat's online database⁷ in time for the World Population Day (11 July). The online table is "Population change - Demographic balance and crude rates at national level (demo_gind)"⁸. Provisional derived statistics on population change are published at the same date. Starting in 2017, population turnover statistics⁹ were added to the population change statistics based on the DEMOBAL data collection.

A news release on <u>First population estimates on 1 January 2017</u> was issued by Eurostat on 10th July. This is regular ¹⁰ news release for this time of the year.

2.2. Completeness

Provisional data on total population, live births, deaths, net migration and statistical adjustment at national level were transmitted by all 31 countries bound by EU regulations (EU Member States and EEA countries), by EU candidate countries as well as by Armenia, Azerbaijan, Bosnia & Herzegovina, Belarus, Georgia, Monaco, Russian Federation, San Marino and Ukraine.

Provisional data on total immigration and total emigration (which are collected on voluntary basis by DEMOBAL questionnaire) were transmitted by 27 EU member states, the EEA countries, Switzerland, FYR of Macedonia, and by some of the other countries listed above.

Eurostat welcomes the fact that the majority of data providers are supplying the data requested on voluntary basis.

2.3. Availability of documentation

The metadata files transmitted to Eurostat by the countries are published at <u>Population change</u> - <u>Demographic balance and crude rates at national level</u>, together with Eurostat's summary report on this data collection.

The primary purpose of the metadata transmitted by the countries together with the data is to allow Eurostat to understand the methodological aspects behind the provisional estimates on population, births, deaths, emigration, immigration, and statistical adjustment, and how accurate they are.

Eurostat is analysing each year the metadata information provided by the countries, targeting the improvements and changes in the methodology. The amount of information made available by the countries varies and often the description of methodology used is not thorough. This is sometimes detailed in additional documentation available via links on national websites, or it is difficult to understand and to asses without further inquiries.

At the same time the metadata need to address the general public. The provided information makes the statistics more transparent to users. Despite the publication of the metadata transmitted by the

countries in Eurostat's metadata report on the demographic balance¹¹, Population team nevertheless is requested to reply a number of questions from users following the publication of the data, on the size of the figures, on the exact meaning of flags (for breaks in series users are asking which precise change in methodology occurred for the country), on differences between the DEMOBAL figures published by Eurostat and those available on the national statistical offices websites. Most of the time the metadata files are providing the information to reply to those questions, but sometimes the Population team is contacting the countries for clarifications.

For a systematic and more user friendly presentation, but also for allowing comparability between countries, Eurostat publishes in its metadata report summary tables with information by country. See some of these tables in Annex 1.

3. USUALLY RESIDENT POPULATION COLLECTION REFERENCE YEAR 2016

The data collection on the usually resident population for the reference year 2016 (URESPOP 2016), addressed to EU Member States, was launched in July 2017. The transmission deadline was 31st August 2017. The data collection is regulated by Article 4 of the Regulation (EU) No 1260/2013.

Countries had the obligation to transmit to Eurostat data (Edamis Webform¹² dataset DEMOMIGR_URESPOP_A) and metadata (reported using the European Statistical System Metadata Handler¹³ (ESS-MH), dataset DEMOMIGR_UREESMS_A).

All the EU Member States sent the requested data and metadata.

Eurostat transmitted the Member States' total usually resident population at national level to the Council for the purpose of the Qualified Majority Voting (QMV) at the beginning of October 2017 as requested by the Council's Rules of Procedure¹⁴.

Eurostat has the obligation to monitor the compliance of the Member States to the European statistical law. Moreover Regulation 1260/2013 obliges Eurostat to produce a report by end of December 2018 to the European Parliament and to the Council on the implementation of this Regulation, including an evaluation of the estimation methods used by the Member States for URESPOP. In the report the Commission (Eurostat) shall take account of relevant information provided by Member States and shall evaluate the quality of the data transmitted, the data collection methods used, the additional burden imposed on the Member States and on the respondents, and the comparability of those statistics (Art.11 of Regulation (EU) 1260/2013).

As communicated to the Member States in the previous Eurostat's working group meeting on Population Statistics (June 2016), following the experience of the first two reporting years on URESPOP collection Eurostat implemented modifications to the Eurostat metadata template for the URESPOP collection. The modifications proposed in the previous working group meeting were targeting to summarise and to better structure in tables the information on the inclusion or exclusion from the reported usually resident population figure of some identified difficult-to-count population

groups and the information of other adjustments which MSs may carry out in order to estimate the usually resident population.

This document reports in Annex 2 an extract from the URESPOP Metadata concept "10.6 Documentation on methodology" for the reference year 2016 as reported by the Member States. Three tables are assessing the inclusion and exclusion of selected population groups and/or, depending on how the MSs obtain usually resident population, make ad-hoc adjustments to correct for other issues.
