

# Quality declaration of Statistics Netherlands

Quality obliges...

The Quality declaration of Statistics Netherlands describes the quality policy, confidentiality policy, privacy protection and information security policy and conformity policy of Statistics Netherlands. The Quality declaration is intended for everyone involved in Statistics Netherlands ('stakeholders').

### Quality policy

The policy of Statistics Netherlands is to guarantee the quality of the statistical information. This involves all aspects of quality of the output. In case of statistics this concerns:

- Relevance and completeness
- Accuracy and reliability
- Timeliness and punctuality
- Coherence, comparability and consistency
- Accessibility and clarity

Statistics Netherlands aims to maintain the continuity and to manage the costs of its statistics by producing them efficiently and by minimising the administrative burden on its respondents and data suppliers.

The quality policy of Statistics Netherlands serves several aims:

- Complying with the mission of Statistics Netherlands
- Maintaining public trust in Statistics Netherlands and its products
- Satisfaction of users and clients

Statistics Netherlands adheres to the international standard of quality ISO 9001<sup>i</sup> and it is also certified for this standard.

Finally Statistics Netherlands continuously strives to improve its quality management system, in line with ISO 9001.

## Confidentiality policy

The confidentiality policy is that Statistics Netherlands guarantees the privacy of the provider of data (persons, enterprises, governmental services and other respondents). Statistics Netherlands guarantees, moreover, the confidential character of the information they provide and the exclusive use of data for statistical purposes.

### Privacy protection and Information security policy

The EU General Data Protection Regulation (GDPR)<sup>ii</sup> applies to Statistics Netherlands. On a regular basis external auditors examine Statistics Netherlands on its compliance by means of the Privacy Control Framework of NOREA<sup>iii</sup>.



Regarding Information security the Government Information Security Regulation (*Voorschrift Informatiebeveiliging Rijksdienst* (VIR))<sup>iv</sup> and the *Baseline Informatiebeveiliging Rijksdienst* (BIR)<sup>v</sup> applies. Statistics Netherlands complies with the ISO 27001<sup>vi</sup> standard.

### Conformity policy

Legislation applies to Statistics Netherlands. For the EU this is the Statistical Law (Regulation (EC) No 223/2009)<sup>vii viii</sup> and the European Statistics Code of Practice<sup>ix</sup>. In the ESS Quality Assurance Framework (ESS QAF)<sup>x</sup> good practices are elaborated. The document 'Conformity to the European Statistics Code of Practice' describes how Statistics Netherlands complies with the Code of Practice.

Furthermore, the European statistics are based on European legislation. The statistics supplied to the IMF come under the Data Quality Assessment Framework (DQAF) $^{xi}$ .

Important legislation at the national level are the Act on Statistics Netherlands<sup>xii</sup> (*de CBS-wet*) and the Archive Act<sup>xiii</sup> (*Archiefwet*).

Statistics Netherlands also determines its own frameworks related to the statistical process and its output. One of these frameworks is the series on statistical methods xiv. The methods in the series are described and published online.
