To fill in

We advise you to complete the questionnaire on a desktop computer or laptop.

Navigate

You can navigate through the questionnaire via the table of contents on the left or via the 'Vorige' (Previous) and 'Volgende' (Next) buttons. Not all items in the table of contents are from scratch clickable. The items in gray will become accessible during the completion of the questionnaire.

agree

With the button 'Akkoord en volgende' (Agree and next) you indicate that a screen has been completed correctly. Before sending the questionnaire, all screens must be approved.

Explanations

The "?" button means there is additional explanation. Press this button if you want to see the explanation.

Save

Data is only saved automatically when you scroll between screens. If you work for a longer period of time in one screen, it is therefore advisable to save the data yourself regularly by pressing the 'Opslaan' (Save) button in the top right corner of the screen.

Save and Close

You can interrupt the completion of the questionnaire with the button 'Opslaan en sluiten' (Save and close). Your previously entered answers will then be saved.

Print

You can create a PDF of the questionnaire at any time via the 'Printen' (Print) button and save and/or print it for your own use.

Foreign Affiliates Statistics

This questionnaire is an important tool to gain insight into the importance that Dutch companies have on the economy of countries abroad.

With effect from the 2020 statistical year, the request has changed and in addition to data from foreign subsidiaries outside the EU, data is now also requested from subsidiaries within the EU. In addition, the question about the employed staff has been changed to "Number of employees" (previously FTEs). The demand for number of daughters is expired, so you must register each daughter separately. Finally, in addition to the existing questions (name of the foreign subsidiary(s), activity, turnover, number of employees) now also data on personnel costs and investments is requested.

The reporting period concerns the calendar year 2020.

If the company has a financial year that does not coincide with the calendar year, it must report on the financial year ending on a date between 1-4-2020 and 31-3-2021.

Filling options

The data about the foreign group companies that are requested on the next screen or screens can, in addition to manually entered, also be entered via a read-in option.

The import option is especially useful if the company has many foreign subsidiaries. Instructions on file format and filling of this file can be found on this site.

A disadvantage is that this choice does not include (partly) pre-filled data from 2019.

The activity codes of (a part of the) foreign group companies specified in 2019 have already been stated and only need to be recoded in the event of a change in activity.

Group companies that score zero for each variable (Net turnover, Personnel costs, Number of employees and Gross investments in tangible fixed assets), for example because it is a "dormant" entity, do not have to be declared.

The activities of the subsidiaries cannot be entered via free text, but via the activity code linked to the business activity. You can look up this code on two ways:

- via a so-called typing module where you can find the correct code by means of free text and this link or

- by means of this search list consisting of approximately 85 possible codes.

You can also access both lists from the input screens.

Wis (Delete): use this button if the listed group company was no longer in your possession during the entire reporting year.

Net turnover: Net turnover consists of all income during the financial year in the normal course of business from the sale of goods, the provision of services and/or the rental income of assets. Excluded from the net turnover are: all taxes, duties and levies directly related to this income and all income not arising from normal business operations.

Personnel costs: Personnel costs include all expenses related to employee benefits during the financial year. Employee benefits are all forms of compensation in return for service rendered by employees or for termination of employment.

Number of employees: The number of employees is the average number of persons who were employees of the foreign subsidiary at any time during the financial year.

Gross investment in tangible fixed assets: Gross investment in tangible fixed assets includes all additions to property, plant and equipment recognized as such during the financial year, excluding increases in revaluations or reversals of previously recognized impairment losses and from reclassifications (transfers) of other property, plant and equipment. fixed assets. Property, plant and equipment are acquired through (rental) purchase, financial or operational lease. In the case of in-house production, this concerns the full production costs. In the case of major maintenance, this concerns the full maintenance costs.
