**1.8 billion euros** is the trade deficit with Indonesia

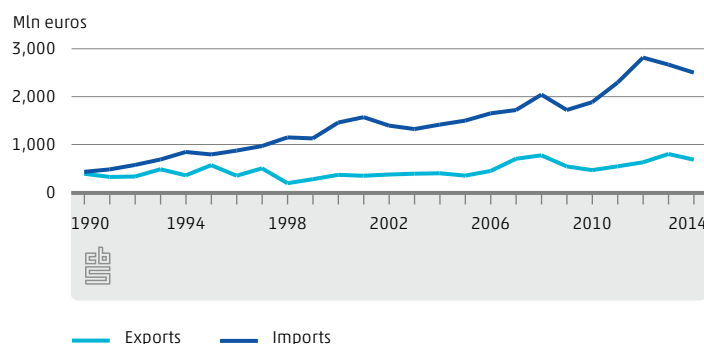

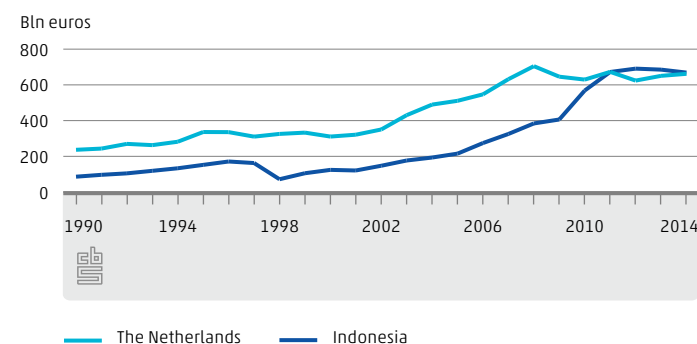

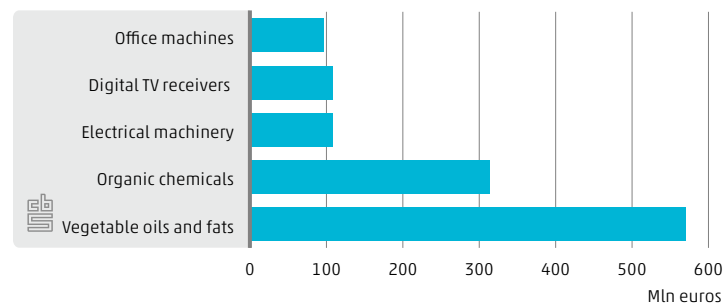
#### Dutch imports and exports of goods from Indonesia (1990-2014)



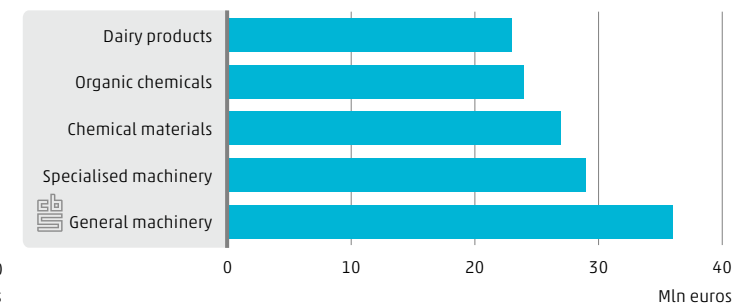
#### GDP at market prices (1990-2014)

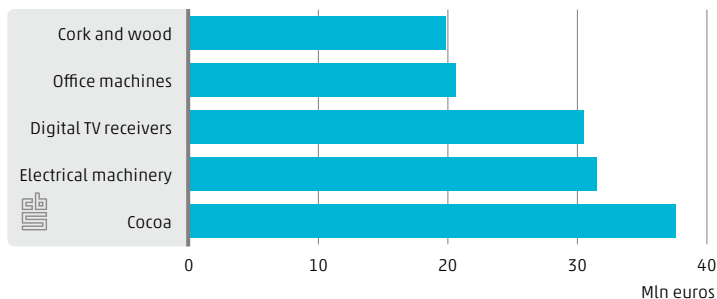

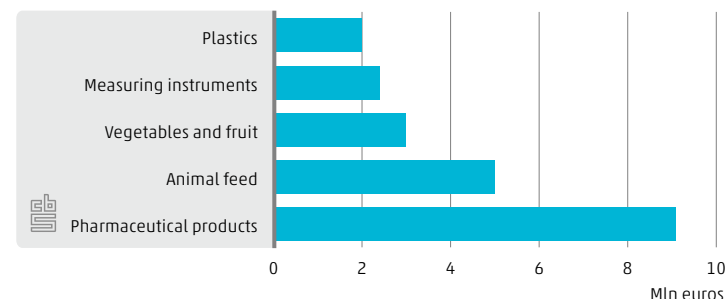

**Top five growing merchandise exports manufactured in the Netherlands (Jan-Oct 2015 w.r.t. Jan-Oct 2014)**



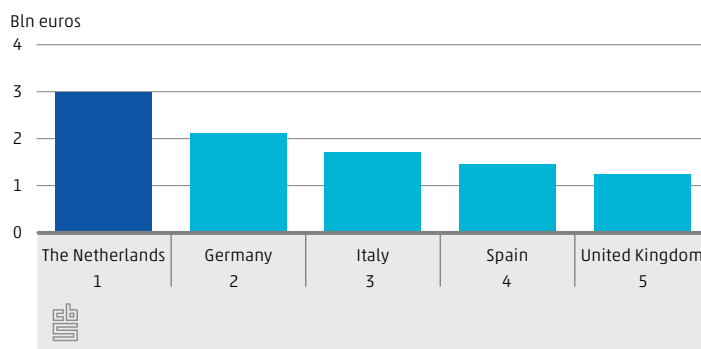
**3,320** firms trade goods with Indonesia (2014)

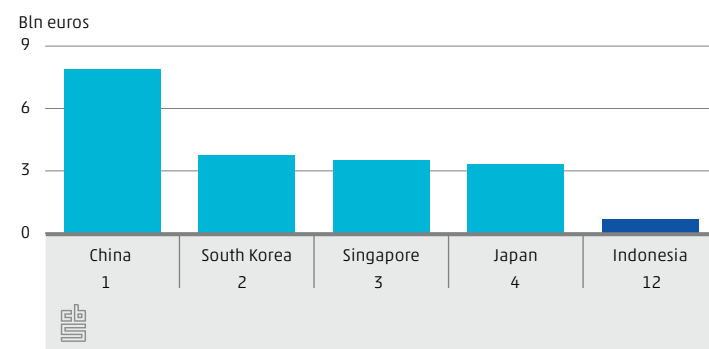


**Indonesian merchandise exports to Europe, 13 bln euros (2014)**

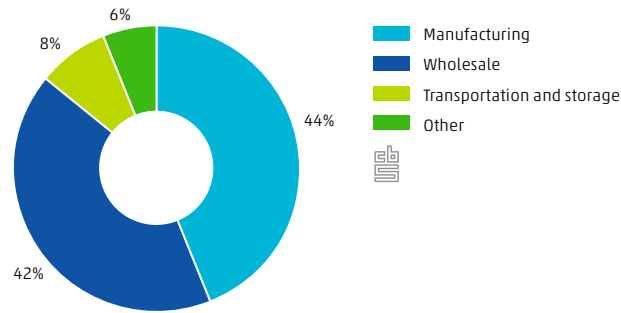

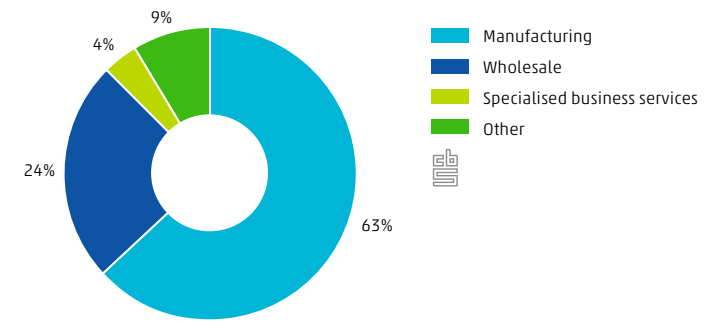

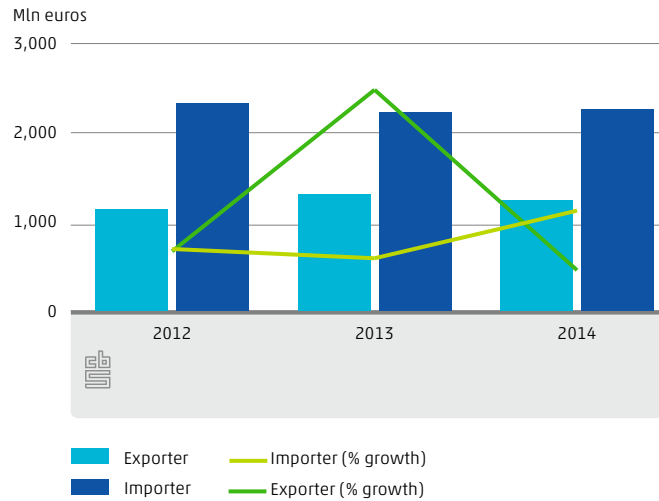
Imports of goods from Indonesia, by business sector (2014)



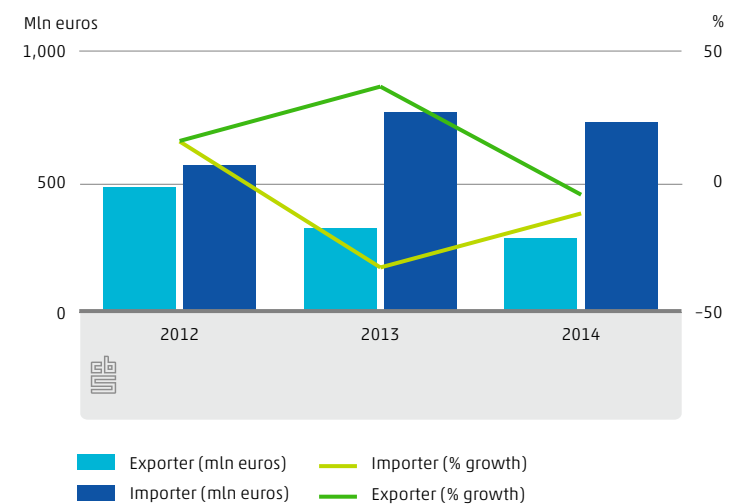
Exports of goods to Indonesia, by business sector (2014)



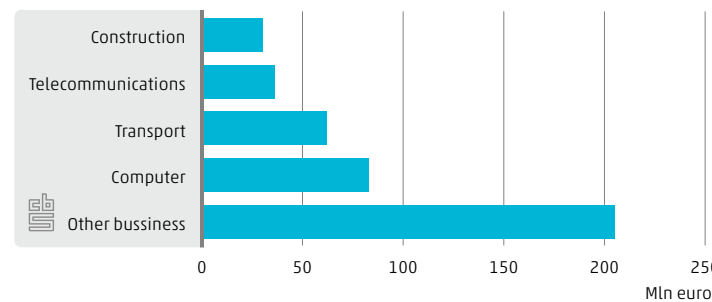
Number of firms exporting to and importing goods from Indonesia (2012-2014)



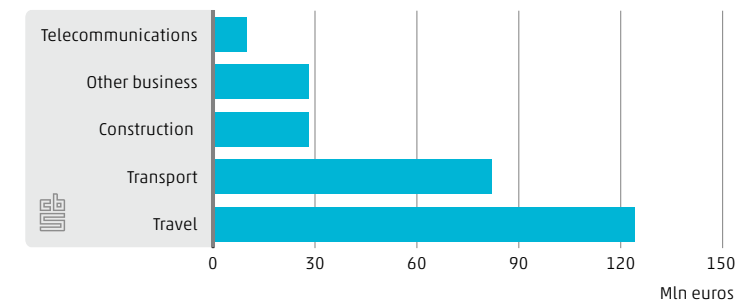
Total imports and exports of services (2012-2014)

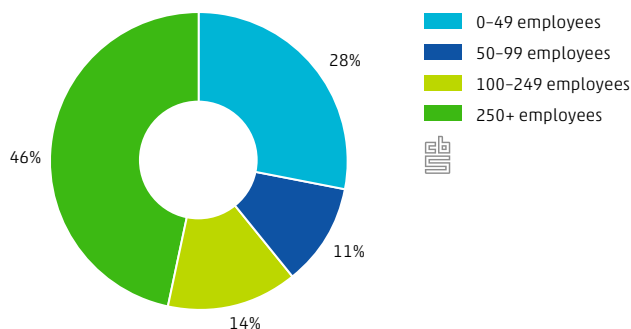

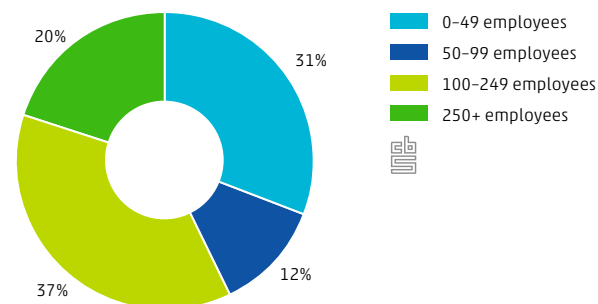

Imports of goods to Indonesia, by business size (2014)



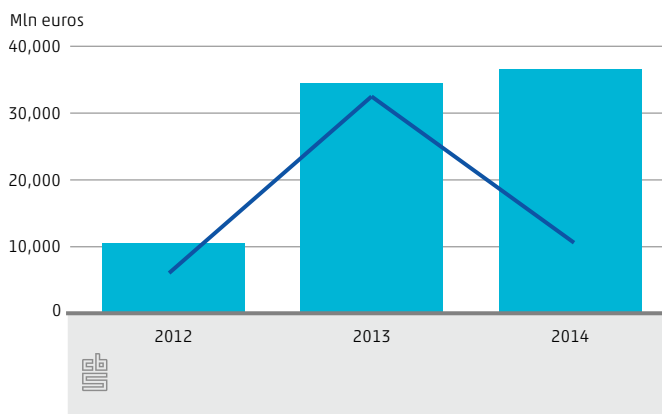

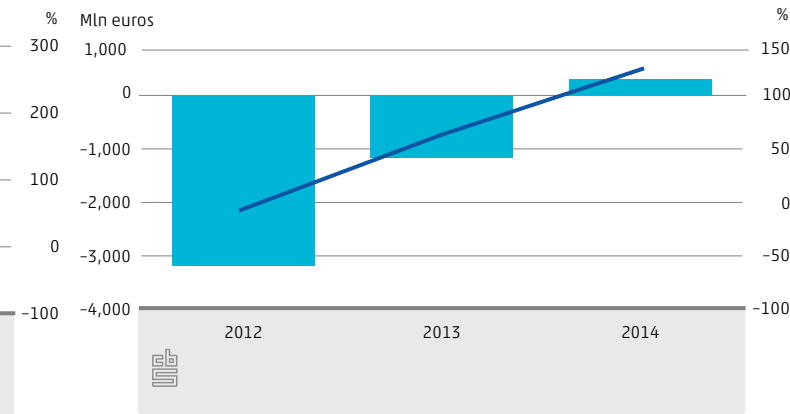


Investments from the Netherlands in Indonesia (2012-2014)

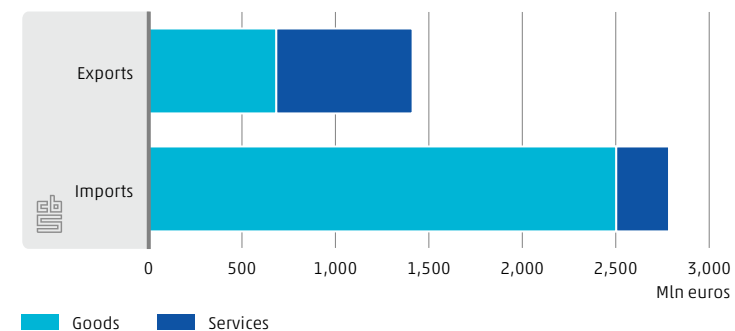

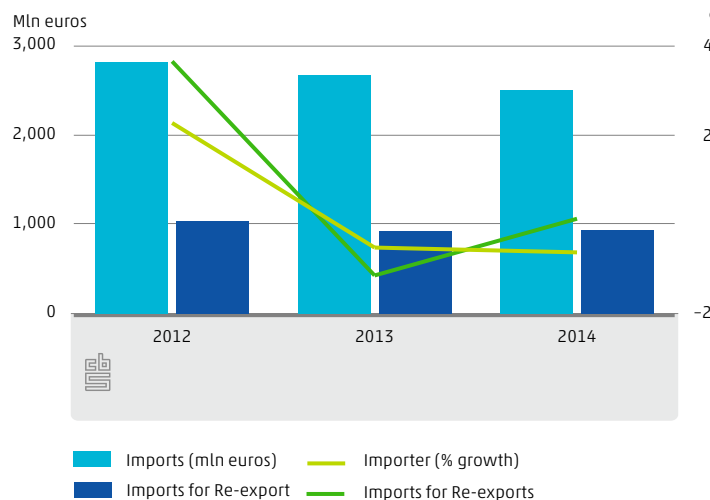

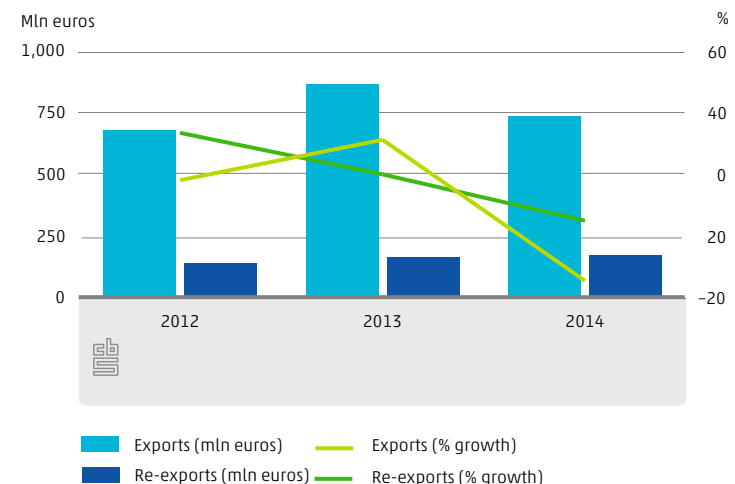
